

## MARINE WARRANTY

The Marine Warranty entitles purchaser of Huper Optik films to a Limited Lifetime Warranty\* from the date of installation against discoloration, cracking and demetalisation provided that the warranty extends only to the provision of new Huper Optik films (labor costs included). The Marine Warranty becomes null and void if improper or negligent care is evidenced or if the purchaser fails to maintain Huper Optik in accordance to prescribed instructions or if any physical damage occurs to the surface on which the Huper Optik film is installed, or if the Huper Optik film is damaged by any cause beyond the reasonable control of the purchaser. The dealer does not warrant that any surface applied with Huper Optik films will not break and in no event shall its liabilities extend to injury, loss or damage whatsoever caused, other than outlined in these terms. This warranty is personal to the purchaser and is not transferable or assignable. No warranty of compliance with any rule, regulation or law is made in relation to Huper Optik films as such requirements vary for different countries. The dealer disclaims all warranties expressed or implied including without limitation, any warranty of merchantability, quality or fitness for any purpose whatsoever other than described herein.

### Warranty Disclaimer

This limited warranty applies only to HÜPER OPTIK window films installed on the interior surface of windows by an authorized Hüper Optik dealer following all installation practices and guidelines as specified by Hüper Optik USA. **THERE ARE NO WARRANTIES WHICH EXTEND BEYOND THE DESCRIPTION SET FORTH ON THIS CERTIFICATE. HÜPER OPTIK USA DISCLAIMS ANY AND ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE OR MERCHANTABILITY, WITH RESPECT TO HÜPER OPTIK WINDOW FILM, EXCEPT AS EXPRESSLY SET FORTH HEREIN. CUSTOMER ACCEPTS THE WINDOW FILM ON AN "AS IS" AND "WITH ALL FAULTS" BASIS. Hüper Optik USA's warranty does not cover improper installation. IN NO EVENT SHALL HÜPER OPTIK USA BE LIABLE OR RESPONSIBLE FOR ANY LOSS OR DAMAGE, DIRECT, INCIDENTAL OR CONSEQUENTIAL, EXCEPT AS EXPRESSLY SET FORTH HEREIN. SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU.** This limited warranty is made in lieu of all other warranties, expressed or implied, and is void if the window film has been subjected to abuse or improper care. This limited warranty gives you specific legal rights and you also may have other rights, which vary from state to state.

This limited warranty is valid only if the Warranty Registration is completed and submitted by an authorized representative of the Hüper Optik USA dealer. The registration must be registered with Hüper Optik USA within (30) days from the installation completion date. Hüper Optik USA recommends that the Customer retain a copy of the Certificate of Registration along with a copy of the invoice from the authorized Hüper Optik USA dealer for the installation of HÜPER OPTIK window film. Any owner desiring warranty service on any HÜPER OPTIK window film covered by this limited warranty must contact the original installing authorized HÜPER OPTIK dealer. Proof of purchase is required in order to obtain warranty coverage.

This limited warranty covers installation in continental United States, Puerto Rico and Canada only. For installation in other countries, contact Hüper Optik USA.

### TO MAKE A WARRANTY CLAIM

Hüper Optik USA reserves the right to verify customer eligibility for this limited warranty coverage.

1. Contact your original installing dealer to initiate a warranty service claim. If your original installing dealer is not accessible, you may contact the Hüper Optik USA warranty department at 1-888-296-3456.
2. All warranty claims must be reported to Hüper Optik USA, and approved for payment by Hüper Optik USA prior to commencement of any warranty related service.
